Our locations are real life search environments where people work, go to school, etc. Pre-trial contact or visits risk the host's losing the opportunity to use the location again in the future.

## Number of Entries

**NW3:** 38 entries

**NW2:** 42 entries

One dog per handler per level/element.

Event attendees are required to adhere to the NACSW [COVID-19 Event Guidelines and Rules](#).

In addition to those guidelines the following changes and guidelines are in effect for this trial at this time due to COVID-19:

- Everyone at the event, regardless of vaccine status, may be required to wear a mask while indoors.
- Pennsylvania currently has no travel restrictions. Please refer to your own state guidelines when deciding whether it is safe to travel. Travelers should still practice appropriate public health measures to slow the spread of COVID-19. These guidelines may be more relaxed or stricter at the time of the trial. - Per the CDC, fully vaccinated (2 weeks after last vaccination with an FDA-authorized vaccination) can safely travel within the United States.

- If you are not fully vaccinated (2 weeks after your last vaccination), you should adhere to the CDC guidelines <https://www.cdc.gov/coronavirus/2019-ncov/daily-life-coping/participate-in-activities.html>.
- Everyone at the event must attest to the following information:

I represent and affirm that to the best of my knowledge and belief: (1) I neither have COVID-19 nor am I waiting for test results; (2) I have not been tested and found positive for COVID-19 or, if I have tested positive for COVID-19, I certify that I have been released by government officials and/or health care providers to resume normal activity without limitations; (3) I have not, during the past 14 days, experienced symptoms associated with COVID-19 including but not limited to fever, cough or shortness of breath; and (4) to the best of my knowledge and belief, I have not within the past 14 days been in contact with and/or exposed to any known carrier of COVID-19. I agree to follow any specific event guidelines, precautions and/or requirements to mitigate the possibility of event participants or attendees contracting or spreading COVID-19. I understand the risks of contracting and/or being exposed to COVID-19 associated with my attendance at this event, and I knowingly accept those risks.

- Everyone at the event is encouraged to maintain social distance and to be respectful of the wishes of others.
- Competitors are asked to bring their own hand sanitizer and disinfectant wipes.

If there are any significant changes or updates after the draw period, entrants will be notified via email. Competitors are responsible for staying up to date on any jurisdictional requirements for their home location as well as the trial location, including any travel guidance.

Details regarding site-specific COVID-19 restrictions that will be in effect at the time of the trial are not known at this time, and may be more relaxed or stricter at the time of the trial.

Details regarding mandatory restrictions and requirements as they exist at the time the final details email will be included in that email. You must comply with these mandatory restrictions. We will attempt to email competitors about any changes that occur after the final details email goes out but we ask for your understanding that there are many tasks that must be accomplished during that time so there may be new details when you arrive at the trial. You will not be required to bring with you any equipment of which you did not have advance notice. If a change such as this happens, we will provide the requisite equipment if we cannot provide you with advance notice.

### **PLEASE NOTE:**

At this time, the Commonwealth of Pennsylvania Department of Health has no travel restrictions. Travelers should still practice appropriate public health measures to slow the spread of COVID-19. These guidelines may be relaxed or stricter at the time of the trial. ## TRIAL ENTRY INFORMATION

### **Trial Entry Open and Closing**

- The draw period for the trial will open on September 5, 2022 at 12pm EST. Entries will be awarded by random draw of all entries received between 12pm EST on September 5, 2022, and 12pm EST on September 7, 2022.
- Trial entry will close at the end of the draw, if the trial and wait list are deemed full. If the trial and wait list are not deemed full, the trial will remain open for entries until they are deemed full or the day of the

trial.

- We will not be taking payment until you are given a space in the trial. If you are given a space in the trial, you will receive information on how to submit payment. You will then have five (5) business days to submit payment by **CHECK OR MONEY ORDER ONLY**.

### **Entry Method**

All entries will be online via the link to the NACSW™ trial entry form provided. Paper and phone entries will not be accepted. Completing the form is not a guarantee of entry. You will receive a confirmation email from [lisa@nose-it-all.com](mailto:lisa@nose-it-all.com) to let you know if your entry has been given a space in the trial.

### **Entry Requirements & Selection**

**A Qualified Entry is one that meets all the following criteria:**

1. Complete the online trial entry during the draw period listed above.
2. The Handler is a NACSW™ member for the 2022-2023 membership year (8/1/22 - 7/31/23).
3. The Dog is registered with the NACSW™.
4. Dogs participating in a trial must be at least one year of age.
5. The Dog has achieved the ORT title (passed all 3 odors) and prior title level at least 14 days before the trial opens for entries. This applies to all levels effective April 1, 2021.
6. Qualified Entry for NW3 – Dog has earned the NW2 title but has not yet earned the NW3 Elite title.
7. Qualified Entry for NW2 – Dog has earned the NW1 title but has not yet earned the NW2 title.

**Trial spaces will be determined in the following manner:**

- Spaces will be awarded by a random draw of all Qualified Entries received during the draw period listed above.
- In the event that you are having technical difficulties with the entry system, please email [trialentry@nacsw.net](mailto:trialentry@nacsw.net) prior to the end of the draw period.
- No dog will be given a space in more than one trial of the same level at a single event.
- You may enter multiple dogs for entry in the draw. However, only one dog/handler per title level will be accepted into the trial. Entry will go to the dog selected in the draw – you may not swap to an alternate dog. If multiple dogs are selected in the draw, you may select which dog you wish to enter. Once a dog has been entered as a second dog/handler entry, you may not swap handlers after the draw to change the entry to a first dog/handler unless the trial is not full.
- If a trial level is not full after the draw of Qualified Entries, then there will be a Secondary Draw of any entries received that did not meet the ORT title or title requirements. These entries will be accepted pending completion of the requirements. **Note:** Dogs must earn their ORT title and prior title level at least 3 days prior to the trial date to be eligible to compete. If the required title or ORT title is earned less than 14 days prior to the event, it is the competitor's responsibility to notify the host that the requirement has been completed.
- If the trial and waitlist are not full after all entries received during the draw period have been processed, entries will continue to be accepted in the order they are received until the trial and waitlist are deemed full.
- For Exhibit Only Dogs (FEO): Dogs running FEO are not eligible to receive titles or earn placement ribbons. FEO results will not be included in the posted trial results. If space remains after all Qualified Entries are accommodated on September 27, 2022, then we will offer spaces for those who wish to run a dog For Exhibition Only (FEO). Second dog/handler FEO entries on the same day will be offered spaces after September 27, 2022.
- The trial host of an event has the right to refuse entry of any competitor or dog for just cause as approved by the National Trial Committee. Just cause includes lack of adherence to NACSW™ rules

and guidelines and the policies outlined in each event entry premium.

- Some trial entries may be given priority entry based on contributions to the organization and the trial process.

You will be notified via e-mail of the results of the random draw by 12:01AM EST on September 16, 2022. If you have a spam blocker on your email account, please configure it to allow email from [lisa@nose-it-all.com](mailto:lisa@nose-it-all.com) in order to ensure delivery of confirmation and information about this trial.

You will then have five (5) business days from notification to complete your payment by check or money order to confirm your space in the trial. Checks or money orders should be made payable to “Lisa Basial” and mailed to Lisa Basial, 1009 Rockledge Drive, Carlisle, PA 17015. **Please make a note on your check or money order indicating for which trial(s) you are submitting payment.**

If you receive a spot and do not plan to accept the entry, please email us at [lisa@nose-it-all.com](mailto:lisa@nose-it-all.com) as soon as possible to let us know. We have no way of knowing if you have received the notification. This will allow us to keep our competitor lists and waitlists up to date. This also gives the next person on the waitlist time to make arrangements to attend if you do not want your spot.

A waiting list for alternates will be started as soon as entries fill. Alternates will be contacted when a space opens and they are first on the waitlist. Depending on last minute trial logistics, the host may opt not to fill cancelled spaces.

NACSW™ reserves the right to cancel a trial if minimum entry numbers are not met.

*Be sure you read and understand the guidelines for this trial before entering. By submitting a registration for this NACSW™ Trial, you acknowledge that you have read, understand, and accept the policies and liability information of NACSW™.*

## CANCELLATION POLICY

The following cancellation policy applies:

- For cancellation of entries at or before 5pm EST on September 23, 2022 – Full refund minus a \$25 processing fee.
- For cancellation of entries after 5pm EST on September 23, 2022, and at or before 5pm EST on October 4, 2022– Full refund minus a \$25 processing fee if host fills your space. No refund will be issued if host does not fill your space. If the space is filled with a discounted or free entry, you will receive a refund dependent upon the income from the replacement entry.
- For cancellation of entries after 5pm EST on October 4, 2022– 50% refund if host can and does fill your space. No refund will be issued if host does not fill your space. If the space is filled with a discounted or free entry, you will receive a refund dependent upon the income from the replacement entry.
- For cancellations that meet the above guidelines, refunds will be issued within 30 days and no later than 14 days after the trial date.
- If you earn the title that makes you no longer eligible for the level you entered, then you must contact the trial host at [lisa@nose-it-all.com](mailto:lisa@nose-it-all.com) to cancel your entry and will be subject to the published cancellation policy. You may opt to change your entry to an FEO entry in this case and will be placed on the FEO waitlist and only receive a space in the trial if the host is accepting FEO entries.
- Entry fees shall not be refunded if a dog or handler is absent, disqualified, or excused by a NACSW™ official or judge.

- *This cancellation and refund policies apply to competitors that must withdraw for any reason including but not limited to injury, illness, emergency, and personal- or work-related reasons.*
- *If the trial cannot take place or be completed by reason of fire, civil disturbances, an Act of God, public emergency or any other cause beyond the control of the trial organizers, then the trial host will make their best effort to provide partial refunds after recouping their expenses.*

## LOCATION DETAILS

### **Trial Conditions**

Modeled after real-life detection work, NACSW™ trials are held in many different locations, with a variety of terrain, under varying weather conditions. Dogs and handlers need to be able to safely negotiate a variety of surfaces, including but not limited to steps, tile, linoleum, carpeting, gravel, asphalt, uneven surfaces, and slippery footing. Handlers should be prepared to deal with a variety of weather conditions, including heat, cold, rain and snow. Trials frequently require covering extensive distances to get to and from the parking area to each of the search areas and generally require that this be done across natural, uneven surfaces. Handlers should be prepared for the physical demands and must be able to navigate the terrain with their dog accordingly. Participants should expect to spend most of the day outside or in their vehicles as there are rarely indoor crating options at trials. Please be prepared for you and your canine partner to deal with all these varying environmental challenges. Handlers should familiarize themselves with potential regional risks and health concerns that may affect themselves or their dogs. Handlers agree that they are entering this trial at their own risk.

### **ADA Site Specific Conditions**

This site is a camp. The outside terrain is grass, gravel, dirt, pavement and cement. The parking areas are gravel and/or grass and some natural shade. The pathways, search areas and dog potty areas may require you to navigate steps, tile, gravel, asphalt, paved pathways, unmanicured dirt pathways, grassy areas, uneven surfaces and slippery footing. Inside search areas and paths thereto may have varying surfaces such as carpet, tile, stone or wood flooring, some of which may seem slippery, and may require navigation of flights of stairs for ingress and/or egress. The search areas are spread out so there may be long walks to the search areas. There are some mild elevation changes. Due to unforeseen conditions, such as weather or change in availability of areas at the location, the expected search areas, parking, and pathways to the search areas may be modified at the last minute.

### **Reactive Dog Parking**

There will be limited reactive dog parking at this trial that will need to be quite far from the number sign. If you park in this area, it is **YOUR** responsibility to know when it is your turn. Please email [lisa@nose-it-all.com](mailto:lisa@nose-it-all.com) if you wish to reserve a reactive dog parking space. Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

### **Unentered Dogs**

**QUIET** and well-behaved unentered dogs may be brought to the trial. Unentered dogs must remain in the competitor's vehicle during the trial day. There will be ample potty areas, but unentered dogs should not be allowed to "play," exercise, or train on the trial grounds.

### **RV Parking**

There is no RV parking available.

### **Running Vehicles or Generators in the Parking Lot**

Limited running of vehicles or generators in the competitor parking lot is permitted only to take the edge off of the heat or cold. Running your vehicle for the entire day is not permitted. Please be considerate of your

neighbors in the parking lot. If you are inconveniencing your neighbors in any way by running your vehicle, you will be required to move away from the main parking area. It will still be your responsibility to monitor the progress of the trial and no one will come to get you when it is your turn to run. Due to unforeseen conditions, such as weather or change in availability of areas at the location, this policy may be modified at the last minute.

### **Smoking**

Smoking, including the use of e-cigarettes, is not allowed on this trial site.

### **Hotels**

Pet-friendly hotel information will be provided with you confirmation email.

## **DOG INFORMATION**

### **Dog Policies**

- All dogs must be on a 6' leash at all times when not being tested. No flexi-leashes while not participating in a competition search.
- Dogs that need space from dogs may wear a red bandanna, to be provided by the dog's handler, to help signal others that the dog needs extra space from other dogs.
- Dogs will be toileted in designated areas and handlers must pick-up and dispose of waste in designated containers.
- Dogs and handlers must stay in designated areas to avoid contaminating testing space, interrupting a test or viewing any part of the testing.
- Competitors should expect to keep their dogs confined in a crate or vehicle when not competing. The logistics of a trial typically do not allow for dogs to hang out on leash in between searches. Competitors should plan to provide their own shade using canopies or shade cloths.
- Refer to Location Details (above) for information on unentered dogs.

### **Females in Season**

Will be allowed to run wearing "pants" at the end of the running orders after all other dogs have been judged. Females in season will be parked and pottied in areas separate from the other dogs while at the trial if the location logistics permit. Handlers must contact [lisa@nose-it-all.com](mailto:lisa@nose-it-all.com) so plans can be made for the female in season.

### **Rules**

### **Liability**

By registering for the trial, competitors and attendees hereby assume all risks of, and responsibility for, accidents and/or damages to her/himself and/or to her/his property, from any cause, and/or to others resulting from the actions of her/his action(s) and/or dog(s). Competitors and attendees expressly agree that the NACSW™; Nose-It-All, LLC; Lisa Basial; Camp Penn and their assignees and/or agent(s) shall not be held liable personally and/or collectively under any circumstances for injury and/or damage to her/himself, for loss and/or injury to property, whether due to uncontrolled dogs and/or negligence of any agent(s), member(s) or employee(s) of said individuals or entities, and/or due to any other cause(s). Competitors and attendees also

agree to assume all financial liability that may be incurred by the NACSW™; Nose-It-All, LLC; Lisa Basial; Camp Penn and their assignees and/or agent(s) due to the actions of themselves and/or their dog(s), regardless of the cause(s).

### **Sportsmanship**

All competitors/handlers and spectators are expected to follow the rules of the NACSW™ and demonstrate good sportsmanship. This includes making sure the hide placements are unknown to the handler prior to testing and kept secret from other competitors. Please do not discuss hide placement or any details of a dog's performance that may provide information or clues to other handlers or may be overheard.

### **NACSW™ Results**

Results for each search and overall will be posted after all searches are completed and scores are verified for you to record your results for your own records. It is your responsibility to ensure your scores are accurate prior to leaving trial grounds. If a discrepancy cannot be verified at the trial, you may be instructed to submit a score card review request. It is not the responsibility of the host or NACSW™ to return score sheets that are left behind or to mail ribbons that are not picked up.

### **Spectators**

Spectating will be allowed at some elements, space permitting and at the Certifying Official's discretion. Spectators may not photograph or video searches. Children under 18 must always be directly supervised by a parent/guardian. An adult accompanying a minor must be present during the searches. No dogs will be allowed in the spectator area. No unentered dogs with spectators are allowed at the trial. Competitors are not allowed to watch the trial at any time. Spectators are reminded that the hide placements must not be discussed and they should not speak with any competitors about what they saw until after the trial is complete. Everyone at the trial site must sign the waiver provided by the host and comply with all event requirements.

### **Videotaping and Photography**

At the host's discretion, a video service and/or photographer may be present during the trial to offer videos and/or photographs for sale to competitors.

If the site allows public video to be taken, handlers may wear visible head or chest cameras to record their searches. You will not be allowed extra time at the start line to get your camera functioning. Please be sure it is ready to go prior to arriving at the search area. Videos may not be made public until completion of the trial day.

No photography or video by spectators or volunteers is permitted.

As a condition of your entry, you agree to allow NACSW™ and/or their agents to video you and your dog during the entirety of the NACSW™ event. These videos are the property of NACSW™. All competitors, through entry at any NACSW™ event, waive any and all rights relative to video broadcast or photography of such event.
